




In 2014, Master Sharon received a breast cancer diagnosis.





The sectors symbolizing family members must be robust and clearly present in the floor plan, without any gaps or deficiencies.

- **Future Outlook (Next 3–5 Years):**

The sectors symbolizing the next three to five years should be strong, complete, and without any missing sections to ensure a positive trajectory.
